- Must be the original owner of a 2008 or newer Warrior Boat, and fishing from and winning first place overall from the eligible boat in either the Alexandria Chain of Lakes Spring Walleye Classic June 5-6, 2009, or the Lake Minnewaska Fall Walleye Classic on Sept. 12-13, 2009. No other tournaments are eligible.
- Manufacturer Contingency Cash eligibility for (2) tournaments total. Eligible boat owners who fished the 2008 Fall Walleye Classic at Lake Minnewaska have (1) tournament remaining for Manufacturer Contingency Cash eligibility and must fish either the 2009 Spring Walleye Classic or the 2009 Fall Walleye Classic as the cutoff for eligibility in 2010 will be all 2009 eligible Warrior Boats. 2009 Warrior Boat owners who have never fished the Spring or Fall Walleye Classics will be eligible for Manufacturer Contingency Cash for a total of two tournaments, with eligibility ending following the 2010 Fall Walleye Classic, or two tournaments total, whichever ever comes first. If you fish both tournaments in 2009, your eligibility ends.
- \$7,500 offered in Dealer Contingency Cash if purchasing a new Warrior Boat from either Bobbers Marine, Glenwood, MN, or Alex Dock/Lift & Marine, Garfield, MN. Must be original owner, and you must be fishing from and winning in a Warrior boat purchased from either dealer listed above. Total eligibility for the Dealer Contingency Cash is (1) tournament. Eligible boat must be a 2008 or newer Warrior boat.
